Objectives and Investment Policy

The Fund seeks total return, which is derived from a combination of capital appreciation and income.

- The Fund seeks to achieve its objective by allocating from 0-100% of its assets among stocks, bonds, Exchange Traded Funds, Exchange Traded Commodities and short-term instruments anywhere in the world. The Fund may invest also in emerging markets such as developing countries of South America, Eastern Europe, Africa and South East Asia.
- The Fund may invest up to 5% in Frontier Market (as defined by MSCI) local currencies exposition. Frontier Markets are a subset of emerging markets that are investable but are smaller and less liquid than the more developed emerging market counties.
- The Fund may hold liquid assets on an ancillary basis.
- The Fund may invest in financial derivative instruments for investment purposes, hedging (including currency hedging) or efficient portfolio management.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within a period of 2 years.

The Fund does not intend to declare and make distributions with respect to the net investment income and realized capital gains, if any, attributable to this class. Accordingly, the net investment income of this class will neither be declared nor distributed. The reference currency of the Fund is the USD and the reference currency of this class is the EUR.

A Shareholder may redeem its shares in the Fund on demand, on each day on which banks in Luxembourg are open all day for business.

The shaded area in the table above shows the Class's ranking based on the Synthetic Risk and Reward Indicator. The risk/return indicator suggests the relationship between risk and potential returns when investing in the Fund. Please note that category 1 does not mean a risk free investment. Historical data, such as is used in calculating the synthetic indicator, may not be a reliable indication of the future risk profile of the Fund; the category might change in the future.

This Fund is in category 5, since it invests in companies listed in the equity markets that are in general characterized by high risk as well as the potential for high returns. Nevertheless, stock markets are subject to unpredictable fluctuations, which can lead to long-term depreciations.

The following risks are materially relevant to the Fund but are not adequately captured by the synthetic indicator and may cause additional loss:

- **Derivative Risk** – Derivative financial instruments are not in themselves investment instruments but rights whose valuation mainly derives from the price and the price fluctuations and expectations of the underlying instrument. Investments in derivatives are subject to general market risk, management risk, credit risk and liquidity risk.

- **Market Risk** - Adverse market conditions, sometimes in response to general economic or industry news, may cause prices of the Fund's holdings to fall as part of a broad market decline.
- **Management Risk** - Performance of the derivatives in the portfolio are dependent on the manager's skill in evaluating and managing derivative exposure.
- **Credit Risk** - Management must take into account the creditworthiness of each counterparty.
- **Liquidity Risk** - There is potential to have difficulty in buying or selling a security.
- **Emerging Markets Risk** - Investing in emerging markets may offer a higher degree of risk as it is an area that is at an early stage of development and may suffer from increased risk of expropriation, nationalization and social, political and economic insecurity. It may also have liquidity difficulties, currency fluctuations, settlement and custody risks and restrictions on buying and selling. Accounting, auditing and reporting standards and practices in emerging markets differ from those in developed markets in respect to content, quality and the deadlines for providing information to investors. It may be difficult to evaluate investment options.

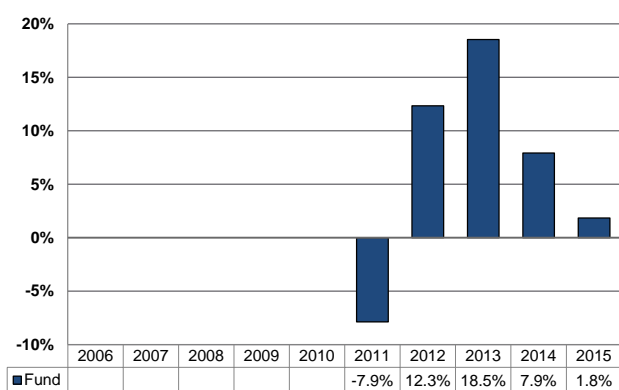
